## **Mascot Design for the Office of the Commissioner for Children**

### **Objective**

The Commissioner for Children (CFC) is looking for a suitable mascot which can be used to promote the activities of this office among children and youths. For the reason the Commissioner is asking students to come up with ideas regarding what the mascot should look like.

### **Conditions**

1. The mascot should be original and likeable
2. The logo of the Commissioner for Children can be used on the character's clothing.
3. The design has to be presented on an A4 sheet.
4. The entry has to portray a full body of the character without any background.
5. Each entry has to have the school endorsement stamp on the top left hand corner of the A4 sheet and the Name and Class of the student below the design.
6. Any medium can be used (pencil, crayons, watercolour, poster and acrylic paints and collage).
7. Each student can present one design.
8. All entries will be acknowledged by the Commissioner of Children upon agreement with the Head of school.

### **Design Procedures**

Outstanding designs will be selected according to the originality and the likeability of the character, and the potential usefulness in CFC activities.

The selected design will be announced by 3<sup>rd</sup> March 2008 and the designer of the chosen character will be presented with a book prize.

The Commissioner for Children will retain the copyright of the chosen design.

A number of best entries will be exhibited at the Ministry for the Family and Social Solidarity, Republic Street, Valletta, between 3<sup>rd</sup> and 7<sup>th</sup> March.

The Commissioner for Children would appreciate the exhibit of all works in the school once these are returned to the individual schools (or local councils) of origin.

### **N. B.**

1. Schools are requested to make a preliminary selection and send the best five entries only to the CFC by the **22<sup>nd</sup> February 2008**. The designs sent to CFC should be mounted on cardboard with a 2cm border around the A4 sheet.
2. The Commissioner for Children would appreciate the exhibition of all works in the school (or local councils) after the five selected designs are returned to the school.
3. In order to prepare the Commissioner's acknowledgement we need a list of the names of **all** the participants together with a digitised copy of the Head of School's signature so this can be printed next to the Commissioner's Signature.

### **Ogġettiv**

### **Kundizzjonijiet**

1. Importanti li dan il-Maskot ikollu karattru oriġinali u simpatiku.
2. Jista' jintuża l-logo tal-Kummissarju tat-Tfal fuq il-ħwejjeġ tal-karattru.
3. Għal skopijiet ta' organizzazzjoni d-disinji għandhom jiġu pprezentati fuq karta A4.
4. Din il-karta jrid ikollha d-disinn tal-karattru biss, mingħajr ebda xenarju.
5. Kull disinn jrid ikollu t-timbru ta' l-iskola fil-kantuniera tax-xellug ta' fuq u l-isem u l-klassi tal-istudent taht id-disinn.
6. Jista' jintuża kwalunkwe medium bħal lapsijiet tal-kulur, xema, akwarell, poster, acrylic u anke collage.
7. Kull persuna tista' ddaħhal disinn wiehed.
8. Kull min jipprezenta disinn jingħata rikonoxximent mill-Kummissarju tat-tfal bi ftehim mall-kap tal-iskola.

### **Proceduri rigward id-Disinn**

Għalkemm din m'hijiex kompetizzjoni, l-idejiet li jispikkaw iridu jintgħazlu skond l-oriġinalità u s-simpatija tal-karattru.

Id-Disinn magħżul jkun imxandar sal- 3 ta' Marzu 2008 u l-awtur (disinjatur) tal-karattru magħżul jiġi ipprezentat bi ktieb.

Il-Kummissarju iżzomm id-dritt tal-*copyright* fuq id-disinn magħżul.

Numru minn/ ta' l-ahjar disinji jiġu esebiti fil-Ministeru tal-Familja u Solidarjetà Soċjali, Triq ir-Repubblika, Valletta bejn it-3 u s-7 ta' Marzu.

Il-Kummissarju tat-Tfal tapprezza ħafna jekk ix-xogħolijiet li jiġu rritornati fl-iskola jiġu esebiti fl-iskola / kunsill lokali.

**N.B.**

1. Liskejjel mitluba li jagħmlu għażla preliminari u jibagħtu biss l-aħjar hames disinji lil ufficcju tas-CFC sat-**22 ta' Frar 2008**. Id-disinji li jintbagħtu, għandhom ikunu mmuntati fuq kartoncin li jkollu bordura ta' 2cm ma' kull naħa tal-karta A4.
2. Il-Kummissarju għat-Tfal tapprezza hafna jekk ix-xogholijiet kollha jiġu esebiti fl-iskloa (jew kunsill lokali) wara li l-hames disinji magħżula jinagħtaw lura lill-iskola.
3. Bil-għan li jiġi preparat ir-rikonoxximent tal-Kummissarju, nixtiequ lista tal-ismijiet tal-partecipanti **kollha**, kif ukoll kopja diġitali tal-firma tal-Kap ta' l-iskola sabiex tidher maġenb il-firma tal-Kummissarju.
